Abatement: Letter required: Before a structure can be demolished or removed, the owner or agent shall document that the requirements of USEPA 40 CFR 61 SUBPART M have been or shall be met. A permit to demolish or remove the structure shall not be issued until the owner or agent notifies the enforcing agency that all friable asbestos or asbestos containing material that will become friable during demolition or removal have been or will be properly abated prior to demolition (Construction Permit required for abatement).
